

PRESIDENT'S REPORT

The Lambton Federation of Agriculture again had a very active year. The following are some of the highlights.

In November we made food donations to Petrolia and Forest food banks. We also attended a meeting with County Council regarding toxic waste disposal at "Clean Harbours". Later on LFA attended monthly meetings of the committee that the Lambton County council put together. We held our annual meeting with Kevin Stewart as our guest speaker and also presented a number of scholarships to Lambton students. Members from Lambton attended the Annual Meeting Convention in Toronto.

In December we again participated with BDO Dunwoody LLP and OMAF in another successful Farm Management and Taxation Day in Wyoming. LFA participated with a booth at John Deere Days at Podolinsky Farm Equipment and helped to sponsor a meeting in Alvinston on Bill 81 the "Nutrient Management Act".

In January the LFA held another meeting for farmers of the "Nutrient Management Act" at Wyoming. From that meeting the LFA put a brief together which was presented to the Minister of Agriculture in early February.

February brought "Food Freedom Day" the day when the average working Canadian has earned enough money to pay for their food for the year. On February 7th OFA President Ron Bonnett and executive member Paul Mistele, Becky Lunn and myself where on CHOK "Talk Back" show with Sue Storr. We later toured and met with farmers and farm groups in the county. Also this month the LFA was presented with a plaque from the Sarnia Lambton Economic Council. February also saw one of the rare times we had to cancel our board meeting because of bad weather.

In March we participated in the Farm show in London and were involved with meetings and lobbying on the Agricultural Policy Framework.

April saw early signs of spring and we completed our yearly donation to area food banks by donating about 5000 lbs of canned goods to the Inn of the Good Shepherd in Sarnia. We made a presentation to Sarnia Council on behalf of the rural residents of Sarnia Township with regards to Transit charges on their property taxes.

The summer and fall months saw us deal with issues such as BSE, Farm Taxation and Classification, high speed internet for rural areas, APF, toxic waste, hydro rates, Canadian Coast Guard, Gas Storage, OSPCA (Ontario Society for the prevention of cruelty to Animals) and Provincial election.

Last year our very dedicated secretary for many years Lois Wakefield announced she wished to retire at the end of our business year September 30, 2002. We hired Cathy Young to replace Lois but unfortunately Cathy was never able to join us because of the ongoing health problems with her little girl Hannah. Our thoughts and prayers are still with Cathy, John and Hannah and we wish for Hannah's total recovery. Lois being the dedicated person she was stayed on an extra year hoping things would work out for Cathy & John. However now we have hired Marilyn Jones, a former director, as our secretary and look forward to working with her. Again Lois we say thank you very much for so many dedicated years.

I want also to say a special thank you to our former MSR Maria Van Bommel and now one of the MPP's representing Lambton. Maria was very dedicated on working on problems for Lambton and Middlesex federation members and I know that will follow through with her as she serves as MPP. Thanks on behalf of the LFA and we look forward to working with you in the term ahead. Also we want to say thank you to Marcel Beaubien for his many dedicated years to producers in Lambton. We wish to welcome Becky Lunn as our new MSR and look forward to working with her.

I would like to close by saying thank you to the farmers of Lambton for allowing me to be their LFA president for the past two years. The farmers of Lambton have always been progressive and active in their county and at provincial level, and one of our future challenges is to move these things to the next generation. I want to thank all my directors for their support. I would especially thank Debbie Coke for her monthly radio reports on LFA activities and vice president Dennis for attending events and meetings when I was unable. To the directors who are retiring thank you for your many years and I wish you all the best for the future. I wish Dennis and his new executive the very best. Finally I would like to say thank you to my wife Anne for her always dedicated support.

Committee Report

Nothing in life is stagnant, and the LFA lives by this rule as well! This committee was without a chair when Vice President Janet Loosemore moved out of Lambton County and resigned from the organization. Deboie Coke stepped in to assume the role of chair in April.

Many of the activities this committee was involved with are highlighted in the President's report.

In conjunction with surrounding county federations, promotional placemats have been designed and printed and are currently being distributed free of charge to restaurants in the county.

MSR Report for Lambton Federation of Agriculture

The Nutrient Management regulations are extensive and may cause a great deal of confusion among farmers and non-farmers alike.

The following operations will be subject to the regulations on September 30, 2003.

- × Operations that are placing new barns on a separate property (previously unused by the owner for livestock production) where farm animals will generate more than 5 Nutrient Units
- × Operations whose expansion means their farm animals will generate 300 Nutrient Units or more. Large livestock operations where there are enough farm animals present to generate 300 Nutrient Units or more will be phased in to the Act July 1, 2005. The Provincial Advisory Committee will make recommendations to the government regarding the phase in of other farms. The government has indicated that the phase-in will not be earlier than 2008 and that there will be funding attached prior to the other farms being phased in.

Beef producers were only the first to be impacted by the international ban on Canadian beef this past spring. Dead stock collectors have closed their doors, processors have laid off staff, sales yards have geared down and now some local abattoirs are closed as well. OFA and the Ontario Cattlemen's Association have signed a Memorandum of Understanding this past year and are working together to assist the livestock industry in their recovery from the BSE (Bovine Spongiform Encephalopathy) crisis. Producers rallied Ottawa to send a message to government that until live animals can be traded with the US, the crisis will only worse.

Another year of lobbying for Safety Net Programs and we are beginning to see signs that the Federal Government understands some of agriculture's requests for changes to the Business Risk Management component of the Agricultural Policy Framework (APF). Agri-Food Minister Lyle Vanclief issued a statement that a review of all elements of the framework will be conducted after the first year of implementation. Since the APF is a five year program, it is critical that if we don't get it right the first time that opportunities for improvements are provided.

OFA continues to develop their "Contract with Consumers" program. This will include information to consumers documenting the quality, safety and affordability of the food that Ontario farmers produce.

The OFA Healthy Futures Water Well Program has now concluded after two years, and it was well received in Lambton County. The program was intended to assist private well owners to prevent pollution of the aquifers across Ontario. To all applicants who have not yet sent in their claim forms please call our office at 1-800-668-3276. Funding is still available through the local Conservation Authorities, 50 % to 100% of certain projects are funded. The funds are made available through the Healthy Futures Program and the Municipalities of Middlesex, Oxford, Perth; London, Lambton and Kent. One of our executive members is now the Director of Finance for the Province. Hopefully we will be able to take major strides in up righting the issue this coming year.

On some brighter notes our club had an excellent fund raising year. Through our battery drive that our local farmers supported whole heartedly (our thanks to all those who donated to the cause). The Junior Farmer Food Booth at Twin Creeks took on a new look this year, and we for the first time sold Corn On The Cob at the plowing match this year. Our presence in the community was not only for fundraising activities but have and will continue to clean a 2 km stretch of the Plank Road in the heart of Lambton, and aided in running the Wyoming Fair, and Brigden Fair Farmer Olympics.

Lambton Farm Safety Association Report

Lavern Wray, as chairman, and Earle Woolaver, as secretary treasurer, keep Lambton Farm Safety running very smooth.

The "Event Safety Trailer", is a mobile safety classroom project entitled "Let's Save Lives". This project was made possible by a Canadian Agricultural Rural Initiative Program grant along with support from 36 local businesses and individuals. The main local contributor was Lambton Mutual Insurance Company with a donation of \$10,000.00 to buy the trailer.

This past summer and fall, a truck was leased for 6 months to move the trailer to different events. Perhaps you've seen our trailer at Child Safety Days, local fairs, Lambton Plowing Match, machinery dealer days, fire department training sessions or another event. Already, participants have had an opportunity to participate in this hands-on display at over 20 events.

Other Lambton Farm Safety activities for 2003 include:

- a successful county annual meeting with almost 100 attending,
- school video and poster campaign,
- · work with Lambton County on the S.M.V. program,
- Agriculture in the Classroom at 2 locations,
- farm safety ads in local papers,
- · good attendance at the provincial safety meeting,
- Farm Safety day camp for children held in July at Alvinston,
- good attendance at the area meeting and our local meetings,

We have applied for an Ontario Trillium Foundation grant to use as a farm visit to every farm in Lambton in 2004. This grant should be approved in December 2003.

Political Awareness Committee Report

On behalf of the LFA members I would like the thank Marcel Beaubien for his interest in agricultural issues during the time he spent as our MPP.

Many organizations prepared briefs to be presented on April 5, 2003, the date scheduled for our annual parliamentarian day. This venture co-sponsored by the Lambton and Middlesex Federations was unfortunately cancelled at the last minute due to weather conditions. Because of commitments by the MP's and MPP's, this day was not able to be rescheduled.

Lambton, Kent and Middlesex Federations worked together to host an All Candidates Meeting held in the auditorium of the Alvinston arena on Sept. 16, 2003. The meeting, attended by all the candidates, was dedicated to rural issues and concerns.

The key issues that cause the greatest concern to Lambton farmers in 2003 was the reassessment and the tax shift to agricultural lands. We are still working on obtaining the details as to where this tax shift came from which resulted in farm taxes being significantly increased. More information will be presented in an upcoming newsletter as the details become available.

Nutrient Management became effective October 1, 2003. If the new government does not change the rules, all viable farms in the province will need an approved Nutrient Management Plan by 2008.

As of writing, the APF has not been signed by sufficient provinces to bring it into force.

Congratulations to Maria VanBommel on her recent election to provincial politics and on her appointment as parliamentary assistant to the Minister of Municipal Affairs. We thank her for her dedication to all Lambton food producers in her capacity as our MSR. We look forward to working closely with her as we continue to address agricultural issues.
