

Presidents Report

The 2009 – 2010 year ended up being both challenging and rewarding. This was my first full term as president of the Lambton Federation of Agriculture. Some of the year's highlights are listed below.

I started out the year with the hope to improve communication between the LFA and the different commodity groups within Lambton County. In March we hosted a meeting with many of the commodity groups and all four local MP's and MPP's. The meeting was very well received by all groups and agreed that we should continue to host these meetings at least once a year.

Our map committee worked very hard at developing the 3rd edition of the Locally Lambton Food and Fun Map. It was bigger, brighter and better than previous years as support continues to grow for this wonderful initiative. The map committee also organized our 2nd annual Locally Lambton map tour which showcases different map participants. The day did not go quite as well as planned and we hope that more focus and advertising can be directed toward this project in the upcoming year.

The political awareness committee continues to work toward a land use policy that can guide us in discussions with municipalities and land owners when issues may arise. This document will be immediately useful as the City of Sarnia is currently reviewing their land use policy and creating a strategy for moving forward. I have been working with this committee to ensure the best use for Agriculture land is a primary issue.

One other project that I have been working with is a Community Food Summit. The priority of this group is to allow all Lambton County residents equal and fair access to locally grown food, while ensuring fair returns for the farmers who produce these foods. This group has already hosted some regional meetings to gain feedback about issues regarding access to local food and will be hosting a Food Summit tomorrow, Saturday, November 20th, to gain more understanding of these issues.

As a board we need to be continually improving and finding ways to connect with the grass roots farmer. This will allow our board to be more educated and responsive when issues arise with any of our members.

Lambton Kent Agriculture in the Classroom

LKAITC committee is operated by volunteers as a non profit organization delivering successful agriculture programs to local school children. Increasing awareness of agri- food industry continues to be the mandate of the committee.

Some of the projects done by LKAIITC are Harvest Days at Ridgetown Campus, Spring Days at Canatara Park; donate to Science Education Partnership to develop agricultural based kits for teachers, and the Healthy Eating Club.

Harvest Days at Ridgtown Campus is very successful. The program is for 6 days and rotates students through 4 stations. A Day in the Dairy, Early settlers, Soils and Seeds, and I Spy -a wagon ride around the campus pointing out the different agriculture buildings and crops. There are about 600 plus students that go through the program.

Spring Days at Canatara Park is in it's second season. Ten schools participated this year with 244 students. This was slightly down from the first year due to a fog day. Topics for the grade 4 students included Farm Foods for Healthy Living, Rocks to Food, Pulleys and Levers and Living with Animals. Harvest Days and Spring Days are curriculum based for grade 3 and grade 4 students.

A donation was once again made to Science Education Partnership (SEP) for updating and developing agricultural related kits for the teachers of Lambton Kent District School Board and the St. Clair Catholic District School Board. Kits provided are Gr. 2 Life Systems-- Farm Animals, Gr.3 Life Systems-- Plants, Gr. 3 Earth and Space Systems--Soils, and Gr. 7 Life Systems-- Ecosystems. Numbers are not in for this year but last year 17 classes did Farm Animals, 51 classes did Plants, 48 classes did Soil and 32 classes did Ecosystems.

The Healthy Eating Club targets gr. 6,7 and 8. The goal of the club is to promote healthy eating while allowing students to try new things, to learn where their food comes from, and to understand the importance that agriculture plays in everyone's daily lives. Each club meets twice a week for a period of 8 weeks totalling 16, 40 minute sessions. Each week focuses on a specific food group and topic. One session per week involves hands on food preparation an sampling. The other session has a producer/commodity person delivering a positive message around the healthy eating of Ontario farm-grown products. Local grown is promoted. This club is very popular and enjoyed by the students. They enjoy the farmers coming in to talk and have many questions for them. The schools this year are Lansdowne Public School-Sarnia, Kinnwood Public School-Forest, Tecumseh Public School-Chatham, King George Public School - Chatham. The funding this year was provided by Sarnia Community Foundation for Lambton County and Chatham Kent Community Foundation for Kent County. With out their support this club would not happen this year.

Our annual gala fund raising dinner called "A Taste of Lambton Kent" is always a success thanks to our strong supporters. The elegant 6 course meal is followed by a live auction which is always a lot of fun. The donations from businesses, organizations, private donators and those attending the annual gala and auction allow LKAITC to continue with their projects.

I have completed my second year working for the OFA. In 2008 I was the interim Member Service Representative (MSR) for Elgin-Oxford while Janine Lunn was on maternity leave and this last year I was an interim MSR for Becky Lunn-Dewitt. The joke around the office was that I have become a maternity replacement specialist. Prior to the OFA, I worked 13 yrs for Fingal Farm Supply in Sales and Customer Service and lived on the family farm south of St.Thomas.

I have enjoyed my year with you and look forward to be your OFA Representative in the future. At time of writing, Becky has announced that she is staying home on her Dairy Farm with husband and two children. All of us wish Becky "All the Best" and thank her for her years at Lambton-Middlesex.

Issues of the Last Year

There are approx. 150 issues that the OFA are working on at any one time. Here are just a few of the major issues:

With the prices plummeting in Pork with the advent of H1N1 (many called it Swine Flu), Beef and grain prices at an all time low, it was decided that we needed a Business Risk Management Plan (BRMP) that would aid farm income as AgriStability has not worked. Your Directors of Lambton Federation of Agriculture (LFA) made appointments to lobby your MPP's to get a BRMP implemented. It was announced at the OFA Convention that Canada needed a National Food Strategy (something that has since been taken up by the CFA) and that included a BRMP. The Ontario Agriculture Sustainability Coalition (OASC) was formed as a combined group who shares the same objective to pressure the government to take action. The OASC has made gains with the announcement that the BRM for Grains & Oilseeds has been extended for another year. Please keep asking your MPP/MP for BRMP programs that are timely, responsive and predictable.

The OFA has been lobbying governments to get permission to control predators (ie. Coyotes). It wasn't until a small dog was taken by a coyote in Toronto that the problem has been noticed. It is time our government officials take some serious action to bring an end to predators killing livestock on Ontario farms, and we have called on OMAFRA and the MNR to take immediate action to protect livestock, dogs, people, and farm businesses from an out-of-control predator crisis.

The Ontario Endangered Species Act has put pressure on some farming operations to continue their normal farming operations. Everything from cleaning a surface drain to tearing down an old barn could be affected. The OFA is working to get fair compensation for the loss of production and cost incurred to protect species.

One of the critical issues for Lambton was the restriction of trucks on Lakeshore Rd. The urban residents were looking to restrict all truck traffic. The LFA worked to support that farms can still receive inputs by truck and truck produced commodities so as to continue with the business of farming.

In 2010 many small local abattoirs were inspected by OMFRA Inspectors and told if they did not meet the new safe food guidelines, for their premises, they would be shut down. The OFA organized a small group of abattoir operators to meet with the government officials and is confident that a compromise can be reached that will allow the production of safe food and that changes to the premises will still be affordable.

The Green Energy Act opened the door to use alternate sources for energy, including wind, solar, and biogas. Much to the Ontario Power Authority's (OPA) surprise they received approx. 16,000 applications for solar power (many from farms) for solar panels when they offered 80.2 cents /kw hr. As a result in July they announced that they had changed their mind and were lowering the rate to 56 cents for ground mounted units. The OFA fought and won the rate of 80.2 cents for ground mounted units where the application was in before the July announcement.

Many were disappointed when the Ontario Government announced that it would start the HST. The OFA were successful in having most farm inputs zero rated for HST and is still working to have exemption at source.

On March 27th the LFA held a MP/MPP meeting where different Commodity Heads could report on their need for government support and receive what the different levels of government were doing.

On June 29th LFA hosted a tour for Bette Jean Crews, President of the OFA. The day started with a radio interview with Bette Jean and Kevin Forbes, President of LFA, followed with a tour of Research Park, Dairy BBQ, and a showcase of the Innovation Award winners at Lauren Van Ewyks'.

On Aug. 26th LFA held its' annual Regional Meeting. OMAFRA's Don Hilborn spoke on Green Energy.

The LFA will continue to hold local events to keep their membership informed.

Foodville

At the 2010 International Plowing Match (IPM) held in St.Thomas the OFA introduced their Foodville Display. It consists of a miniature farm, processing plant and community to show the progression of food from the farm to retail. It was very well received as a training tool for children and the general public and emphasizes the need to Buy Local and a National Food Strategy. ENVIRONMENT REPORT

The Lambton Federation learned that a new natural gas pipeline has been approved for St. Clair and Dawn-Euphemia Townships. On March 10 the Ontario Energy Board (OEB) gave its approval for the Dawn Gateway Pipeline Limited Partnership to construct a 17 kilometre pipeline and "associated facilities" in southern Lambton County.

The pipeline is part of a larger project in the Dawn Gateway Pipeline Limited Partnership between Spectra Energy and DTE. The 34 kilometre pipeline will connect the Dawn Compressor site in Ontario and the Belle River Mills storage site in Michigan.

In a previous decision, the energy board gave Union Gas Limited the permission to sell the St. Clair Line to DGLP, as part of the overall project, on the condition that ratepayers receive \$6.4 million. As a part of the decision, DGLP will be able to charge for transportation charges for any natural gas traveling through the pipeline. At one point during the discussion there was a desire to make the pipeline a federation project and therefore local constituents would have virtually no "say" in discussions surrounding the pipeline. The OEB denied this application.

The Environmental Committee watched the roller coaster ride taken by the various sources of generating electricity. Wind power, solar power and biomass production as well as smart meters and Time-of use measurements became and remain topics of concern for the rural public. The rupturing of the Enbridge Pipeline in Kalamazoo introduced a variety of questions concerning our underground environment and the treatment of such problems by the participating companies and now the possibility of burning biomass at Lambton Generating Station has opened a door of hope and opportunity for our area. What a whirlwind this year has been!

FARM SAFETY REPORT

The Lambton Farm Safety Committee held its annual Farm Safety Day in Forest this year with over 120 children in attendance. We also saw over 700 children attend Agriculture in the classroom at Brigden Fair this year. Students, parents and teachers came from schools in Sarnia, Port Lambton, Corunna and Petrolia. Identifying root vegetables, identifying household poisons and other hazardous materials, learning about the incredible egg, were some of the workshops offered. We thank the organizing committees and volunteers who donated their valuable time for this very effective and enjoyable day at the fair.

The Video Lending Library saw an overhaul this year with new videos on personal safety, water safety, fire safety and drug safety being added by the Canadian Red Cross and Community Safety Net. POLICY ADVISORY COUNCIL REPORT

Policy Advisory Council Members: Ken Dunlop, Dennis Bryson, Lauren Van Ewyk

This past year we have attended 4 PAC meetings. Two were scheduled as regional meetings, being held in Guelph (January), London (October), and two at the Doubletree in Toronto. At these meetings we had opportunity to have our member concerns addressed, in particular the poor regulation and monitoring of animals at the stock yards, as some have had good animals become condemned. Other issues addressed involve the ability for young farmers to become established agricultural businesses, MPAC regulations, problems with trespassing on the farm. The Buy Local movement continues to be driving our federations to be creative and develop buy local maps for their members. We also received updates on continuing files regarding Carbon trading, drainage task team, and Business Risk Management.

The January meeting focused on the National Food Strategy that the OFA is heading up, with the support of the Canadian Federation and various other provinces to devise a strategy that ensures Canadians have access to safe, nutritious food that is grown here in Canada which is sustainable for farmers to produce. The members would like to see this "grass-roots" movement be developed by the federation and spearheaded by them. There is discussion to gain support from businesses rather than specifically the governing bodies. This is a revolving file that will never be laid to rest, as food security is expected to become increasingly scarce, and consumers are expected to demand more accountability in the future.

The April meeting centered on predation and the expected changed to the ministry acts. Presentations from OMAFRA, and MNR were well received. The discussions centered on whether the currently EFP programs are sufficient and if further regulations on farmers should be imposed. The consensus is that farmers should not be responsible to control the predation problems they are facing solely at their expenses, nor are the current programs sufficient to address the needs of farmers. Farmers need to follow a "best practices policy", however should not suffer losses due to out of control wildlife populations that have arose. IT is believed there need to be additional training to officers that evaluate losses as it appears to significantly vary between regions, and further the amount of compensation must increase.

In August, we discussed the current land use policy. This policy had already seemingly been adapted. There was very little desire to change the currently policy. Most representatives did not want to see the severance regulations changed, with the exception of some younger farmers in particular. Much of the discussions focused on this problem, as many counties have various regulations that are enforced.

The October meeting was intended to address the "Open for Business" initiatives that the province has asked the OFA to spearhead. There were no speakers at this PAC meeting, and there were little imperative discussions as it appeared that much of work has already been completed. The members felt that OFA needs to address the over-regulated issues effecting farmers, and streamline the process to have these issues dealt with.

We say good-bye to Ken and Dennis this year. They have been essential members to our PAC team, and have done a wonderful job in representing you! All the best in your future endeavors.

MAP/PROMOTION REPORT

The 3rd edition of the "Locally Lambton Food & Fun Map" was declared a great success this year.

We had 47 participants on this year's map being a considerable increase in those who participated on the 2008 map and we had more variety of producers advertising. Forty thousand maps were printed with most of them in circulation.

We feel the project was a success and helped promote the local products in Lambton County. The group will be able to do a reprint of the maps in 2011 and a new version will be made in 2012 while our website (www.locallylambton.com) is available to join at any time.

We were thankful for the support of the Sarnia-Lambton Business Development Corporation who assisted us in obtaining a large grant. We also want to thank the municipalities, Sarnia Tourism, Sarnia-Lambton Chamber of Commerce, Lambton County Health Services & the Lambton County library system for their support and distribution of maps.

Details for the 2011 map tour will be made available on early spring.
