## Resolutions Submitted for the 2018 OFA AGM by the Lambton Federation of Agriculture

# Lambton Federation of Agriculture – Resolution OFA (November 2018) Laws Prohibiting Animal Activists to Stop Livestock Vehicles

WHEREAS the presence of Animal Activists is increasing while farmers and truck drivers in livestock vehicles are stopped at intersections, stuck in slow moving traffic or entering/exiting a plant; and

Whereas farmers and truck drivers are concerned when activists are walking directly in front of moving vehicles, hanging off trailers to water the animals; and entering their blind spots of the vehicle; and

WHEREAS farmers and truck drivers have put guidelines in place to be proactive and avoid any health and safety issue or serious accident, but it is increasingly becoming more stressful on the farmer or truck driver having the public (Animal Activists) stop their livestock vehicles; and

WHEREAS farmers and trucking companies are finding it more difficult to retain employees who are continually being harassed while in the livestock vehicles;

THEREFORE be it resolved, that the OFA seek information, assist County Federations to address this issue and lobby the government to create laws prohibiting individuals to walk in front, hang off or stop livestock trucks at intersections and/or entering or exiting a plant.

# Lambton Federation of Agriculture ~ Resolution OFA (November 2018) Municipalities Disposing of Animals Killed on the Road.

WHEREAS farmers are legally obligated in how they dispose of deadstock; and

WHEREAS municipalities only have suggested guidelines for disposing of animals killed on the road or elsewhere; and

WHEREAS some are dumping carcasses on back lanes or roads attracting predators, spreading disease, and leading to environmental issues; and

WHEREAS after the response from a municipality advising that after discussions with the Ministry of the Environment, Municipal Staff is now aware that they are also subject to the Environmental Protection Act in the disposing of animal waste. This has its own requirements which differ and, in

some ways, contradicts the Conservation Act. Both Ministries have advised wildlife (roadkill) is unique and difficult to interpret and enforce.

THEREFORE be it resolved that the OFA work with the different Ministries to develop strict rules for municipalities to dispose of animals killed on the road.

#### Recycling and End Use Options for Farm Plastics

WHEREAS farm plastics use is increasing in handling forages; and

WHEREAS there are fewer farm plastic disposal options available to handle bale wrap, mesh, twine, etc. and fewer end uses available for these recycled farm plastics; and

Whereas farmers are having to dispose of their farm plastics at landfills sites and that landfilling is neither environmentally nor financially feasible;

THEREFORE be it resolved, that the OFA work with it's members, recyclers and the government to seek recycling and end use options for the disposal of farm plastics.

# Lambton Federation of Agriculture ~ Resolution OFA (November 2018) Livestock Community Sales

Whereas the Livestock Community Sales Act, R.S.O. 1990, c. L.22, last amended in 2009, outlines the responsibilities of the inspector, the ministry and the seller; and

Whereas the inspector must be an Ontario licensed veterinarian; and

Whereas each inspection at each community sale may result in unfavorable rulings for the seller, in which the seller may be fined for not following the expectations of the Livestock Community Sales Act; and

Whereas each inspector may exercise varying levels of discretion upon inspection and therefore confuse sellers of the definition of permittable and condemnable livestock.

Therefore be it resolved, that the OFA seek absolute clarification and request uniformity among inspectors for its members.
