The Vote was then passed to floor – no opposition from present members. *Motion passed*. Motion will be sent Joanne Fuller for distribution to proper channels within OFA.

2. Ratification of Constitutional Amendments [distributed to members in AGM booklet and available of the LFA website]

Gary Martin discussed the rationale as to why the amendments were necessary. The discussion was around aligning the constitution to be in sync with other organizations setup. Amendments were show on screen, as well as provided to members. Gary asked to have these new amendments accepted by the members. George Dickenson *MOTIONED*. Dave Ferguson *seconded*. *Motion Carried*.

The new constitution will be updated and made available to members on the website.

3. Open to the Floor

Emery Huszka discussed the Mental Health initiative that the Grain Farmers of Ontario are participating in. Brendan Byrne the Essex district rep created a video of the importance of mental health. Emery reminded everyone that they can look at the GFO website for upcoming events. If members have questions about accessing mental health services, they can ask the Executives. Emery discussed a resolution that was passed, in highlighted concerns of some over the Grower Pesticide Safety Course. The GFO Board is going to send a letter to general farm organization asking them to contact government to have a review of the Grower Pesticide Safety Course and how it can be improved.

President's Message

Gary highlighted his report which was included in the AGM booklet for members. Gary discussed the videos that the LFA created this year [one shown at the beginning of the meting, one will close the meeting]. Gary also discussed the numerous meetings that were cancelled at the beginning of the year, and how they got moved to online.

Gary discussed the changes to the two websites – LFA and Locally Lambton. Any feedback on the sites can be sent to Gary. The radio spots and the videos created this year were also discussed and members can find a list in the AGM booklet.

Gary talked about the letters that had been sent to various government agencies, all of which are listed in the AGM Booklet.

The events that were held this year, some in person before March and those that were virtual are all listed in the AGM Booklet. Members are asked to check them out.

The Lambton Federation of Agriculture's "This is Agriculture" video was featured in the show line-up at the Starlite Drive-In Theatre in Crediton, Ontario all summer.

Gary wants to remind everyone of the Mental Health resources available on the LFA website.

Gary asked George Dickenson to speak about the plastics initiative. George talked about the plastics initiative that is taking place at his farm, being conducted by the University of Guelph. Their farm will be one of the farms that are testing the new plastics products. George is hoping to reach out to Cleanfarms about recycling it.

OFA MSR Message – Joanne Fuller

Joanne highlighted the number of members in LFA. She also discussed how OFA was busy with COVID-19, including virtual career fairs, and webinars. Joanne discussed the Feeding your Future initiative – information on the programs and career information and information for Employers were all shared with members. Part of this is letting people know what agriculture jobs are. Always in Season: A Toolkit for Local Food Practitioners was discussed. Success of the 6x16 Food Literacy to cook 6 meals by the time they are 16 – learning how to cook. Letters to local health units and police departments telling them what agriculture is all about. Worked with SLEC including post-pandemic planning committee. Joanne pointed out Better Farming Magazine – your discount card is in there.

OFA Directors Message - Crispin Colvin, Zone Director

- -talked about the internet project
- -highlighted the importance of rural schools
- -PAWS and Trespass Acts both came into effect after much work and commodity collaboration. PAWS Act replaces OSPCA.
- -Lobbied for continued investment in rural infrastructure roads and bridges
- -Worked with both levels of government, and CFA, on climate change particularly with regard to carbon sequestration and that agriculture should receive credits for work already being done
- -Lot creations issues needing to make sure we keep agriculture land
- -Mental Health initiatives were supported. Local federations developed initiatives to support their local areas. OFA lobbied to support the need for Agricultural Mental Health awareness and assistance. This was recognized at CFA as well as a Canadian Agriculture issue.
- -Conservation Authorities act is being reviewed and we are part of that, discussing what they should deliver, how and the costing and funding or CA's. Lobbied successfully to have agriculture represented on CA board.
- -Food safety when pandemic started. The issue of food hoarding. Government needed to know that Ag was a necessary service.
- -Member surveys to gauge the impact of COVID on OFA and what was needed for farms to thrive mental health support and financial support
- -Working to meet demands of seasonal labour last year. There are still labour shortages this year.
- -OFA sits on OMAFRA's Jobs Recovery Committee to develop strategies to stimulate Ontario's Economy
- -Worked with the Province on the Ontario Made logo so consumers could find and support Ontario grown product. This is part of Producing Prosperity campaign as the government is investing in rural Ontario.
- -Freedom of Information issue wanted all farm businesses and their information. Farmers pushed back and filed appeals. The person looking for information dropped request. Push back was strong.
- -Involved in Canada Food Day supporting Always in Season, aimed at increasing local food sales, enhancing agriculture and agri-tourism. Local has taken on a whole new meaning, instead of relying on import.
- -Lobbying for reduced Red Tape regulations for abattoirs, looking to streamline inspections system. Looking to find qualified people to do the job.
- -Involved in the Thames River Phosphorus Reduction Collaborative, looking at ways to reduce runoff and testing water and soil to improve farming practices

- -Clean Fuel Standards issue, OFA is supporting higher green fuel initiatives. The CFS needs to recognize the value of agriculture in environmental stewardship. Producers should be recognized for Best Management Practices and carbon sequestration.
- -Mental health issues grain farmers have done a great job. "In the Know" session. Grain farmers have information on their website.
- -Canadian Centre for Food Integrity released its report on agriculture and consumer trends. It found that 87% of Canadians trust the food system and trust that we will continue to supply Canada with safe, fresh and affordable food. Despite being only 2% of the population, we are trusted by almost 9 out of 10 Canadians.
- -Great videos done by Lambton to highlight local agriculture.
- -Public Trust will continue to be an important lobby effort throughout the coming year.
- -Shout out to OFA Head Office Staff. New building, but no one can get in and see what has been done.

Guest Speaker: Cathy Lennon, General Manager, OFA

Cathy was able to present her PowerPoint and highlighted her career in agriculture. She discussed the projects that Joanne and Crispin highlighted in their reviews.

2020 Agriculture in Technology Video

The "world premier" of the video was tonight. Gary and the Board are working on getting this presented to local politicians and staff.



- Our annual meeting was held virtually on Feb. 25th. The guest speaker was Brad Goodhill, Fire Chief from Warwick Fire Dept.
- We co-sponsored a meeting with Lambton Federation of Agriculture on Mental Health and Coping Skills and Tractor Safety speakers were Lauren VanEwyk of Wellspring Counselling Services and Dean Anderson Strategic Advisor for WSPS.
- Elections were held Agnes Dickenson, Chair; Carlie Douglas Cox, Vice Chair;
 and Earle Woolaver Secretary/Treasurer
- Our next meeting was May 3rd
- We planned our Safety Day. It was held virtually with children able to access videos from July 1st, 2021 until July 8^{th,} 2021 they could watch them anytime during that period and parents could discuss the videos with them. Topics were electrical safety, bicycle safety, farm safety, water safety, chemical safety, stress management, hearing protection, and dog safety.
 - 53 children participated. They were then asked to submit a poster depicting something they had learned. We were very happy with the participation as we were the only group in Ontario to run this event.
- We met again in August in person at this meeting we discussed videos that we want to have made for our own use. Topics discussed were: grain bin safety, visibility at night, hearing, and distracted movement walking ,driving etc.

We also had Heather Derks, a OFA Farm Policy Analyst, who overviewed a snapshot of recent instances that point to the reasons that the OFA Board is interested to update the Land Use Policy position statement. They had input from PAC to see where want the policy to go.

August 2021

At this meeting Lambton County President used this meeting to announce our board's decision to donate to move help move Hay West. At this meeting we also discussed what the membership wanted to see with CAP funding opportunities and how the new policy framework (between the Federal government and Provincial governments) could better support our membership.

January 2022

This was our PAC meeting which was an orientation for new PAC members elected at the OFA AGM in November. We discussed how to determine what goes before the OFA board to help them identify the issues. We all had breakout rooms where we discussed what we want PAC to focus on this year. We also picked members from PAC to represent us at the steering committee, that plans the PAC meetings going forward. It was decided we would have 4 members represent us including myself.

2021-2022 Lambton Federation of Agriculture – President's Report Prepared by Gary Martin

The second year of my serving as President has continued much as the first year ended, without us meeting in person.

The uncertainty of closures and emergency measures are impacting our day-to-day activities and planning into the future, and no community or sector is immune.

While some have seen this as a disservice, some greater good has to come from this. One is the ability to attend more outside meetings (virtually) without the need for travel.

Social media has been expanded with the addition of LinkedIn profiles for the LFA and Locally Lambton, and an addition of a YouTube Channel for hosting the many video that we've had the opportunity to produce ourselves along with partnerships with other organizations. This in addition to the standard Facebook and Twitter accounts.

If you check out our YouTube account, you will see the segments from our last big meeting, the Lambton OFA Regional Meeting. One is a great video of a slide show created and presented by Brooke talking about all that we had done up to that point in the year. Also, our guest speaker Mark Robinson - the Storm Hunter, our Scholarship presentations, and a presentation from our Director Crispin Colvin.

You will also see upcoming segments from our Local Helping Local video series co-produced with SLEP and our videographers Frameworks Media.

Of course, all of this takes a greater understanding of the technology, and the realization that there are still lots of areas in Lambton County where the technology is not available to participate fully in our discussions.

Since we made the move to online monthly meetings via our newly acquired Zoom license, there hasn't been one meeting cancelled due to the lack of quorum. A few meetings have started late as directors rolled in off their tractors or in from barns and not have to worry about cleaning up and travelling to Petrolia to participate in the meetings. Before the change, we regularly had to cancel 2-3 (or more) meetings a year.

With the focus to online, we've had the chance to participate in more outside meetings than ever before, and forge partnerships across the county, and into the surrounding counties.

Collaborating with Lambton Farm Safety allowed us to leverage our Zoom license for special Farm Safety meetings. I've had Meetings with the OFA President Peggy Brekveld, PAC Meetings, and many committee meetings with the Airport Action Working Group, Sarnia-Lambton Chamber of Commerce, SLEP, Middlesex Economic Development, and Lambton College on a regular basis.

It will be different, fingers crossed, going into the coming year, and we hope that we can have a big barbeque this summer, celebrating our 80th Anniversary in a proper manner. In anniversaries past, they've even organized a dance to celebrate. That would be something...

Speaking of our 80th Anniversary, last winter, after going through the items we had in storage, I realized that March 1941 was the date of the first meeting of the Lambton County Farmers Association, (changed to the Lambton Federation of Agriculture, after joining the OFA).

In 1981, the LFA celebrated their 40th anniversary with a commemorative book. In 2001 the LFA also created a book of memories of the previous years as an addendum to the first book.

For our 80th anniversary, we thought we would like to do something similar, however a book would be too difficult to produce, and honestly, probably wouldn't be read by many people. Since there was so much electronic content already available (the LFA started its first website in 2002), we thought we'd present the retrospective all online.

I'd like to bring attention to the Notes section of our Financial Statements (included in this booklet) where it lists all the donations we've made to various organizations over the last fiscal year (up to September 30, 2021) - Note 4 specifically.

We have made the decision to help those in need while we see some cost savings from not holding inperson events. The OFA in turn has done so as well with their sponsorship of certain donations we've made towards HandsToTable.ca, as well as a generous sponsorship towards the London Children's Museum, which is developing and will be building an agricultural exhibit. The Exhibit will hopefully be completed when the lockdowns end.

Other donations I'd like to highlight are the Food Bank donations (there's a video on our YouTube account), and the donation to the Beef Farmers of Ontario to help move Hay West to drought-stricken areas of northwestern Ontario.

Other Events of Note (not mentioned specifically in Brooke's August Report):

We hosted 2 all candidates meetings in September, organized on short notice. One for the Sarnia-Lambton riding at the Brigden Fairgrounds, and one for the Lambton-Kent-Middlesex riding at the Alvinston Fairground's new pavilion. We had a bit of a rain storm at Brigden, but luckily we were safe. The rain storm held off long enough at the Alvinston one for us to clear out before we got soaked.

Guest Speaker Biography



The Honourable Rob Black has worked in the rural, agricultural, and leadership arenas for much of his working career.

He has had close involvement in 4-H and other leadership programs, such as Junior Farmers and the Advanced Agricultural Leadership Program (AALP). He credits his involvement in these programs with allowing him to develop the skills that would lead him to apply to be a senator. He has been involved in 4-H for almost 50 years in all aspects of the program, at the local, provincial and national levels and is a Past President of the Canadian 4-H Council.

Rob was Ward 5 Representative on Wellington County Council. He has also been Manager of the Ontario Research and Development Challenge Fund, and President of the Ontario Agricultural Hall of Fame Association and the Wellington County Historical Society.

Rob worked with the Ontario Ministry of Agriculture, Food, and Rural Affairs (OMAFRA) for 15 years. Following his time at OMAFRA, he spent 5 years as the Executive Director of 4-H Ontario. Rob then accepted the role of Executive Director of The Centre for Rural Leadership, which morphed in to the Rural Ontario Institute (ROI).

In 2012, in recognition of Rob's significant contributions to 4-H across Canada over many years, he received the Queen Elizabeth II Diamond Jubilee Medal. In 2013, Rob was awarded the Outstanding Leadership Program Director Award from the International Association of Programs for Agricultural Leadership (IAPAL) and in 2016, Rob was made an Honourary Member of the Canadian 4-H Council.

Rob applied to be a senator in July 2016, after some prompting from his son, Tayler. In February 2018 he received a call from the Prime Minister, summoning him to the Senate to represent the province of Ontario. The Prime Minister told Rob specifically that he wanted him to bring his background in agriculture, rural community development, and leadership development to the Senate.

On February 27, 2018, Rob was sworn in as a senator representing the province of Ontario. Since then, he has been working on several issues of importance to Canadians through his role and is a member of the Standing Committees on Agriculture and Forestry; Social Affairs, Science and Technology; Rules, Procedures and the Rights of Parliament; and, the Joint Committee on the Library of Parliament. Senator Black has been the Chair of the Canadian Senators Group (CSG) since its inception.

In February 2021, Rob was recognized as one of the Top 50 Most Influential People in Agriculture by Canadian Western Agribition.

In July 2021, the Canadian Produce Marketing Association recognized Senator Black as the 2021 Produce Champion. The annual Produce Champion award is given to a Member of Parliament or Senator who has been supportive of the produce industry and effective at bringing industry issues to the forefront on Parliament Hill.

Rob and his wife Julie live north of Fergus, ON and have four grown children and three grandsons.
